





SOLICITORS REGULATION AUTHORITY

Firms regulated by the Solicitors Regulation Authority (the "SRA") are required to collect, report, and publish date about the diversity make-up of their workforce.




The survey was carried out across June and July 2023, with a 59% response rate across the London office.











Do you consider yourself to have a disability according to the definition in the Equality Act 2010?






Did either of your parents attend university by the time you were 18?



What was the occupation of your main household earner when you were about 14?


